**TERMS AND CONDITIONS**

- Performers should ensure that this form is completed and returned to the organisers. Fax to 9367 7438, post to 16 Marriot Road, Keilor Downs, VIC 3038, or scan and email to [info@vikingsdance.com](mailto:info@vikingsdance.com) . Entry forms should be returned by **June 13, 2009**.
- All performers must be aged under 16 as at June 28, 2009.
- Commissions on pre-paid ticket sales can be earned by performers if 20+ tickets are sold. For 20-49 tickets sold, commission is \$2 per ticket. For 50+ tickets sold, commission is \$5 per ticket. Commission is only payable on ticket sales submitted before Monday June 22. Contact the organisers to request your tickets.
- Registration Fees of \$10 per performer is to be paid prior or on the event day, failure to do so will result in disqualification.
- All performers hereby agree that the organisers of this event (Vikings Sports Club Inc), their officers, employees or agents ("the Organisers") will not be liable for any damage or injury irrespective of the cause that may be incurred or sustained whilst participating in the event.
- Each performer indemnifies the Organisers against any loss or liability incurred by the Organisers arising from any claim or proceeding by any person in respect of any wilful or negligent act by the performer.
- All performers are responsible for their own equipment and possessions. No responsibility will be taken by the organizers for any lost or damaged equipment or personal possessions.
- All performers are responsible for providing their backing music on Audio CD.
- This is a strictly drug and alcohol free event. Breaking this rule will result in instant disqualification of the performer and their group/crew.
- Performers must report at the venue at 2pm at the latest on the day of the event.
- Pre-show rehearsal times will be emailed to all crews in the week prior to the event. Only 1 stage rehearsal is permitted per dance crew. Performers should arrive on time ready to perform.
- The judging panel's decision is final.



### COMPETITION RULES

- Majority of the performer's dance must be RnB or Hip-Hop styles
- A minimum of 4 and maximum of 15 people can participate in each group. Solos are permitted during the performance but must not exceed 4 x 8 counts.
- Each individual performer can enter in one crew only.
- Performances must be between 3 and 4 minutes. Going under or over those times will lead to automatic disqualification.
- Singing or other use of microphones is not allowed.
- For safety reasons, any props used should be small enough to be carried by the performers. Prop set up time is limited to 1 minute and props must be removed immediately after the performance.
- Swearing, explicit language and/or behaviour must not be part of the performance or music.
- Performers will perform once only, in random order (drawn on the day of the event).
- Prizes will be awarded for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places, based on the totals from the judges.

Audience (Crowd support)	20%
